MINUTES OF ARBELA TOWNSHIP REGULAR MONTHLY BOARD MEETING

August 12, 2019

The meeting was called to order by Supervisor Joe White at 6:00 p.m.

MOTION: By Jody Hunt to approve the minutes of the July 8, 2019, township board meeting.

SECONDED: By William Jacobi, all ayes, motion carried.

MOTION: By Mary Warren to pay bills and payroll. **SECONDED**: By Jody Hunt, all ayes, motion carried.

Supervisor White gave the fire board report. There were 3 structure fires, 0 grass fires, 0 other fire, 18 Power line standby, 1 mutual aid, 2 motor vehicle/pedestrian accidents, 5 misc. calls, 0 false alarm and 31 E.M.S responses. The completed fire truck should be done by the end of the year.

Deputy Glumm gave the police report. There was 0 arrests, 19 tickets issued, 30 property inspections, 25 vehicles investigated, 29 persons investigated, 1 paper served and 4 assists to other departments. There were 4 assaults, 2 burglaries, 1 larceny, 1 stolen vehicle, 11 accidents, 6 traffic violations, 1 false alarm, 11 inspections, 10 misc., 1 assist to EMS and 4 assist to other police agency.

Supervisor White gave a road update. The Road Commission is scheduled to grade next week and we will be spreading calcium chloride before Labor Day. Lewis Road between Arbela and Birch Run Road will be shut down as they are putting in a new tube. The Road Commission has been trimming trees that are hanging over the roadways ready to drop. The Road Commission has put four tubes on Swaffer Road and once the sand settles they plan to asphalt it. They are also putting a tube on corner of Stanley and Baker Drive in the subdivision. They plan to asphalt Stanley Drive up to the tube.

MOTION: By Jody Hunt to have Supervisor White go to the Road Commission and request that they not pave Swaffer Road and Stanley Drive because tubes have been put in and we dongt want dips in the new asphalt, or if the Road Commission is willing to give us the \$25,000.00, have Stanley Drive paved up to the new tube.

SECONDED: By Mary Warren, all ayes, motion carried.

Tim Anderson said he is having Deputy Glumm look at 3 blight violations and he received 5 new ones today.

Supervisor White read the recommendation from the Planning Commission on the rezoning of Victor Ill.

MOTION: By Jody Hunt to amend the Arbela Township Zoning Ordinance (2002) and rezone parcel # 79-003-016-400-0400-00 (275 ft. x 300 ft.) located on Barnes Road from A-1 Agriculture to RR-1 Rural Residential for Victor III.

SECONDED: By William Jacobi. Roll call vote. Mary Warren, yes; William Jacobi, yes; Wayne Schultz, yes; Jody Hunt, yes; Joseph White, yes. Motion carried.
