There were 2 structure fires, 2 grass or brush fires, 1 Automobile/Recreation vehicle fire, 1 Power line standby, 3 mutual aid, 5 Motor Vehicle/Pedistrian Accidents, 1 Motor Vehicle accident requiring extrication, 1 misc. call, 2 false alarms, and 16 E.M.S. Responses. The fire chief, assistant fire chief and Sharon Keinath are going to South Dakota on January 29 and if they are satisfied the fire truck is ready, they will bring it back to Millington. Millington has received \$23,000.00 in donations to offset the cost of the \$105,000.00for new tanks and face masks. CPR training is complete and there now are 13 first responders. January 27 they are getting a new paging system from 911. The initial cost is free, but we have to pay to replace them going forward.

Deputy Glumm gave the police report. There were nine arrest charges.

Tim Anderson, zoning administrator said there are a couple of cases he is still dealing with at present.

Supervisor White said the road commission put sand at various intersections throughout the township and they filled in some pot holes on Barkley Road.
