## MINUTES OF ARBELA TOWNSHIP REGULAR MONTHLY BOARD MEETING

## March 9, 2020

The meeting was called to order by Supervisor Joe White at 6:00 p.m.

**MOTION**: By Jody Hunt to approve the minutes of the February 10, 2020, township board

meeting.

**SECONDED**: By Wayne Schultz, all ayes, motion carried.

**MOTION**: By Mary Warren to pay bills and payroll. **SECONDED**: By Jody Hunt, all ayes, motion carried.

Supervisor White gave the fire board report. Fire Chief Russell and Commissioner Jentzen brought the new fire truck to the hall for everyone to see it before it is put into service. Commissioner Jentzen said there were a total of 26 runs including one structure fire. Supervisor White said the other tanker was out for repair. They added four new fire fighters, 3 of which are Amish. Fire Chief Russell talked about the bread truck that needs replacing. It was purchased in 1991 and he said it would cost upwards of \$100,000.00 to replace.

Deputy Glumm gave the police report. There were 7 incidents. One non-aggravated assault, 1 B&E, 1 hit and run, 2 operating under the influence, 3 traffic offenses, 1 warrant, 10 traffic crashes, 1 injury complaint, 11 misc. complaints, 1 misc. traffic complaint and 1 hazardous traffic citations/warnings issued. Computer in police car is in for repairs.

Supervisor White said we had a court date February 26 but it was resolved before it went before the judge.

Supervisor White said Road Commission has been doing some grading on gravel roads as it has dried out a little. He also said Tuscola Rd. is breaking up quite bad.

Supervisor White read the resolution from the planning commission on the Walden rezoning. They voted to approve the rezoning.

Tuscola Road ó Willard to Lewis Road. Re-milled, graded and re-asphalted. \$108,855.00.

Baker Drive ó Willard to Pine Court. \$52,040.25 (will be paid from excess funds paid to road commission last year for work they did not complete).

Barkley Road ó Arbela to Birch Run Road, Limestone. \$25,000.00.
