There were 2 B&Eøs, 1 fire assist, 2 larcenies, 2 warrant arrests, 2 failure to report crashes, 2 false alarms, 8 crashes, 1 assist MMR, 1 assist animal control, 2 neighborhood trouble, 1 driving while license suspended, 1 family trouble, 1 blight, 17 citations/tickets issued.

Supervisor White said we have a February 26 court date scheduled for a blight problem.

Supervisor White said the gravel roads in the township are in bad shape and there is a water problem on Murphy Lake Road.
