Fire report. 2 grass fires, 1 other, 3 automobile fires, 1 power line standby, 3 mutual aid, 2 motor vehicle/pedestrian accidents, 0 misc. calls, 1 false alarms and 13 E.M.S. responses. They had a fire board meeting on July 6. They looked at bids for new air packs and 12 turnout gears. Cost \$99,551.00. They hope to reach 70 to 80 thousand towards this cost through donations. We have 25 firefighters with 4 still in training.

Deputy Ryan gave the police report. Calls for service were 105. 1 alarm, 3 threats/harassments, 13 911 hangups, 3 MDOP, 3 B& Eøs, 24 medical, 19 suspicious/Misc/Animal/welfare checks, 17 traffic complaints, 2 larceny, 3 CPS/DHS, 6 traffic collisions, 4 domestics, 1 civil complaint, 1 trespass, 2 liquor inspections, 1 runaway, 1 stolen vehicle, 1 warrant, 7 traffic stops.

Supervisor White said the road commission asphalted over 2 culverts on Tuscola Road. They installed a culvert on Stanley Drive but havenøt asphalted over it yet.
