

MINUTES OF ARBELA TOWNSHIP REGULAR MONTHLY BOARD MEETING

August 10, 2020

The meeting was called to order by Supervisor Joe White at 6:00 p.m.

SECONDED: By Mary Warren, all ayes, motion carried.

MOTION: By Mary Warren to pay bills and payroll.

SECONDED: By Jody Hunt, all ayes, motion carried.

Fire report. Next meeting in September.

Deputy Ryan gave the police report. Calls for service were 81. 7 threats/harassments, 16 Traffic violations, 10 911 hangups, 1 MDOP, 13 medical, 3 fire, 11 suspicious/Misc/Animal/welfare checks, 17 traffic stops, 1 larceny, 1 CPS/DHS, 6 traffic accidents, 3 domestics, 9 civil complaint, 2 liquor inspections, 1 fraud.

Supervisor White said the all three culverts are installed on Tuscola Road. The gravel township wide to be spread on Wednesday, August 12.

Supervisor White read the resumes from two assessors that applied for the position of assessor for Arbel Township. First was Marie Canterbury. She is a level 2 assessor and presently doing assessing for Thetford Township. She is charging \$10.00 a card which would be \$16,060 a year. The second was David McArthur from Snover. He is a level 3 assessor. He is concurrently doing 4 units. His salary would be \$21,000 a year.

MOTION: By Mary Warren to authorize Supervisor White to set up a contract for one year with Marie Canterbury.

We have had to refund all of August and most of September hall rentals due to Covid 19.

Supervisor White read the bids for garbage contract from Emterra Environmental USA, Republic Service and GFL Environmental Inc.

Emterra Environmental USA bid a 10 year contract as follows for garbage and recycling:

First year \$22.95 per unit per month \$275.40
Second year \$23.57 per unit per month \$282.84
Third year \$24.23 per unit per month \$290.76
Fourth year \$24.89 per unit per month \$298.68
Fifth year \$25.57 per unit per month \$306.84
Sixth year \$26.27 per unit per month \$315.24

Seventh year \$27.00 per unit per month \$324.00
Eight year \$27.74 per unit per month \$332.88
Ninth year \$28.50 per unit per month \$342.00
Tenth year \$29.28 per unit per month \$351.36

Republic bid a five year contract as follows for garbage and recycling and they would furnish containers:

First year \$16.08 per unit per month. \$192.96 a year
Second year \$16.56 per unit per month \$198.72 a year
Third year \$17.06 per unit per month \$204.72 a year
Fourth year \$17.57 per unit per month \$210.84 a year
Fifth year \$18.10 per unit per month \$217.20 a year

GFI Environmental Inc. bid a ten year contract for garbage and recycling and would pick up an unlimited amount of large items/bulk waste with no advance notice. They would charge \$4.75 extra per unit per month for yard waste pickup. Bid is without waste pickup. Amounts as follows:
