They voted to send out specs for new rescue truck to 5 or 6 companies. The cost for the truck is going up and probably won't be delivered for 14 to 16 months once they place the order. Sharon Keineth is applying for a grant for the firemen's gear.

Supervisor Hunt read Deputy Coleman's police report. For the month of June 26 complaints were taken. The police car is due for an oil change in another 1000 miles. At that time Dennis at the county will be completing some maintenance to the vehicle and we will have a county car.

Supervisor Hunt gave the road update. All the roadsides have been mowed once and Al will be starting over after the rain this week. The gravel roads have been graded and chloride spread. As for the bridge on Belsay Road north of Birch Run Road over the creek the outside beams are unstable. The plan is to put guard rails up and narrow the road down to one lane over the creek. The other alternative would be to keep road closed until 2024 or 2025.

Supervisor Hunt introduced Adam Flory from Smith Bovill law firm. He gave us an extensive overview of what his law offices could do for the township.
