Supervisor Hunt gave the road update. Arbela Road east of Barkley Road a 60 ft. tube going in over Pinkham Drain is not done yet. They will put the tube on Lewis Road in the spring of 2022. All the gravel has been spread and the last chloride application has been applied. The road commission might have the cement abutments installed on Belsay Road north of Birch Run Road by the end of September.
