The specs were mailed out last Friday for the Rescue truck to six different companies. The Turnout Gear prices ranged from 81,000 to 119,000. Sharon Keinath is applying for a grant to help offset the cost.

Supervisor Hunt read Deputy Coleman's police report. For the month of October 34 complaints were taken. There were multiple vehicle crashes this months including an increase in car vs. deer reports. Three assault complaints were investigated. One illegal entry into a residence was investigated. The radar is still acting up occasionally. It is software related.

Supervisor Hunt gave the road update. The berm was removed on Arbela Road and all the white lines have been painted on the five half mile roads we approved in June.

We entered into a contract with Parker's Propane to pre buy 4500 gallons of propane at \$1.79 a gallon. The price ends March 31, 2022.

Half of the Covid Relief Funds have been received (152,868.50) and we are working closely with the auditor as to what we can spend it on.
