Fifty six traffic stops were conducted with 11 citations issued, all of which had speed involved. On November 13 there was an injury crash on Arbela Rd. near Belsay Rd. We are still waiting for the push bumper for the new police car.

Road requesst for next year have been turned in to the county.

The first call he was burning without a permit and the fire department was called. The second one he had a permit but there was no one watching the fire.
